# Official Statement

WHEREAS, the American Reinvestment and Recovery Act of 2009 and the Stimulus initiatives throughout the nation, region and State are fueling the economy and forging exciting opportunities for job growth and new careers in Connecticut, and the following organizations are providing ways for students and workers throughout the Nutmeg State to both gain knowledge and leverage their ability thus creating greater skill capacity for the kind of competitiveness required to keep Connecticut a leader in cutting edge economic innovation; and

WHEREAS, work has been called the finest expression of the human spirit; and

WHEREAS, given the thousands of occupations in Connecticut's economy, planning a career can be formidable; experts agree that the ongoing process of career development is essential for all individuals to maximize their personal potential, as well as for the continued health of our economy; and

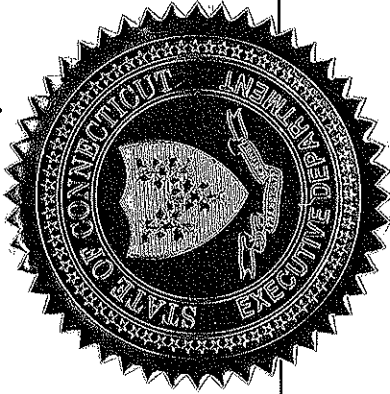
